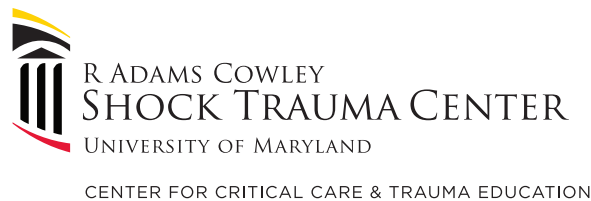

ATCN COURSE DESCRIPTION: The Advanced Trauma Care for Nurses (ATCN) course is taught concurrently with the Advanced Trauma Life Support (ATLS course) for physicians. This program has been endorsed by the American College of Surgeons, Committee on Trauma, MD Chapter. Benefits of ATCN include an educational, collaborative, synchronized team approach to trauma care with the participants of the concurrently taught ATLS course.

ATCN was developed to teach established standards of trauma care and practical, life-saving skills. The course is designed for experienced nurses working in the pre-hospital setting, emergency department, critical care unit and operating room who wish to increase their knowledge and practical skills in managing critically injured trauma patients.

ATCN OBJECTIVES: Upon completion of this program, the nurse will be able to:

1. Demonstrate concepts and principles of primary and secondary patient assessment;
2. Establish management priorities in a trauma situation;
3. Demonstrate management priorities necessary when dealing with the trauma patient.

The course includes didactic presentations on initial assessment, airway management, abdominal trauma, thoracic trauma, shock, head and spinal cord trauma, burns, extremity trauma, pediatric trauma, trauma in pregnancy and stabilization and transportation.

The ATCN skill stations are as follows: Initial Assessment & Management (Practice & Testing), Airway Management, Hemorrhagic Shock, Pediatric Trauma, Head Trauma, Spine & Extremity Immobilization, ATCN Pretest Review, ATCN Triage Scenario Discussion.

The Society of Trauma Nurses (STN) is the national oversight organization for ATCN. The ATCN program verifies successful completion of the ATCN course and provides continuing education credit for completion of a course. STN does not certify or credential nurses.

ENROLLMENT: ATCN courses are offered on a monthly basis in conjunction with the ATLS courses held at the Center for Critical Care & Trauma Education at the R Adams Cowley Shock Trauma Center in Baltimore. Inquiries regarding class availability may be directed to the Course Coordinator at 410-328-9773/3662. You can also enroll via this website: mdcot.org. Please note on the registration form your choice of course dates. Every effort will be made to honor the participant's first choice, however class size is limited. In the event that the selected courses are full, the individual will be contacted for additional course date choices.

Registration deadline for courses is 20 days prior to the course date to allow for delivery of materials. Please type or print legibly and include all information requested, as CE certificates and course material mailing labels will be prepared from this form. This course is offered to nurses only.

CONTINUING EDUCATION: The Society of Trauma Nurses is a licensed continuing education provider in the State of California Board of Registered Nursing. Provider Number CEP 11062. This course has been approved for 19.0 credit hrs.
